Why seek an ASD evaluation?

- Impaired speech development

- Sensory problems including hypersensitivity to sounds, taste, or touch
- Overly concrete/rigid thinking
- Aggressive behavior, such as hitting, biting, or yelling

Testing Specifics

Components of an Test

You will initially receive a **Free Consultation** to determine whether an evaluation is appropriate. Once complete, a typical autism evaluation assesses the following domains:

- Behavioral assessment using the Autism Diagnostic Observation Schedule—2
- Cognitive/Intellectual assessment
- Extensive interviews with caretakers and real-world observation

The Testing Process

- The first step involves a series of in-depth interviews with the parents, teachers, and other caretakers in the client's life. In these sessions, your psychologist will collect key data to include in the final report.
- The second step is the direct testing phase in which your child's behavioral, cognitive, and emotional functioning will be assessed in a comprehensive, yet therapeutic way. During these meetings, your psychologist works to form a good connection with your child and to make the testing process enjoyable.
- The final step in the testing process is to analyze the testing data and integrate it along with the interview data into a comprehensive report. Your psychologist will then meet with you to review the results and create a personalized treatment plan to help with parenting, education, socialization, and extra resources for a successful life.
